Uncertainty over the future of Alexandra Palace continues as the Council, the Firoka Group and supporters of the Save Ally Pally campaign continue with their three-way game of tag wrestling over the crumbling edifice, to the dismay of local residents.

Since the original scheme was thrown out by the courts for lack of proper consultation, Firoka and the Council's trustees have been engaged in further negotiations over the terms on which they are willing to move forward.

This process has been made even more complicated by the bizarre decision, before final terms were agreed and Firoka signed up, to allow Firoka to "run the palace" and receive the income from events bookings. That "licence" was cancelled, but the receipts have not been returned and are now an added complication. In the

meantime, the decision to allow Firoka to receive trust income has been referred to the Charity Commission by Save Ally Pally (www.saveallypally.com).

However, there are a few certainties: the building needs a vast amount of money spent on it to bring it fully into use (possibly as much as £34 million); it continues to deteriorate as time passes and the work is put off; and we are as far away from a solution as we were when the whole process started two to three years ago. Pretty depressing really especially for those of us sitting on the committees which have been discussing the same topics for so many years without any real progress being made. But our representatives will soldier on in the hope that, eventually, some good will come of it and the palace will be restored to its rightful place in the community.

# Redston Road flood

In July last year the water main in Alexandra Park (on the lower road near where the Farmers' Market is held) burst, resulting in serious flooding to about 30 houses in Redston Road.

Flood waters poured along our roads and Priory Road was closed to traffic for most of the day. Rob Worth, a WERA member, made a video of the flood (http://www.youtube.com/watch?v=U6OMy7WiRlw). The emergency services and representatives from Thames Water and the Council were

quickly on the scene.
Thames Water accepted responsibility for the resultant damage but the flooding caused great distress and inconvenience to the residents involved, more so because in 1976 the same main had burst, causing similar damage to properties. Residents wonder if it will happen again.

WERA organised a public meeting with Thames Water managers in October. Twenty Redston Road residents attended this meeting together with local councillors. Residents wanted the trunk main where the burst had occurred to be replaced, not merely repaired, but the managers said that the current national investment programme was only replacing "distributor mains", that is, those that connect up individual houses: renewal of trunk mains would cost much more and lead to even more disruption. The managers have since met with the Council Emergency Planning Officer and Alexandra Park managers to see if the local impact of any future burst could be mitigated.

# WERA YAHOO GROUP

Dick Hudson has set up a WERA Yahoo email group. A Yahoo group operates by everyone in the group receiving all the messages that are sent and any recipient can then reply to the message sender or to the whole group. Group members' email addresses are not made public and members can opt out of receiving messages if they wish. The other feature of a Yahoo group is that all the messages are archived and anyone can access the messages (even if not a member of the Yahoo group – although obviously access to a computer and the internet is needed). Currently there are about 80 members of the group.

Many of the messages are requests for tradespeople and services (builders, plumbers, IT consultants, etc.) and a useful directory of recommendations is being built up. Information about local events is regularly sent out and there has been a very lively debate about whether or not there should be a path across Redston Fields.

# Path across Redston Fields

There has been a lively discussion amongst WERA members about whether or not there should be a path across Redston Fields.

A large majority of responses on the Yahoo email group was in favour of a path. Supporters said that mothers with buggies could use the path as well as children at the local nursery school. The headteacher of a Muswell Hill primary school said it would be part of her plan to encourage parents and children to walk to school. Others referred to the "muddy quagmire" and said that an attractive path would enhance the area.

Objectors feared that a path could lead to more traffic



# **Priory Common**

WERA members continue their work to make Priory Common more attractive.

# Parking and traffic on Priory Road

WERA has taken up residents' concerns about the large vehicles parked on the north side of Priory Road which block visibility for drivers coming out of Warner Road and Danvers Road.

The Council traffic department says that it can only take action if the vehicles are parked illegally. The local removal company whose vans park on the road has recently agreed

to make sure its drivers avoid parking near road junctions.

Three years ago WERA carried out a speed survey of Priory Road traffic which resulted in the installation of the vehicle activated traffic signs which say "30 MPH Slow Down". Whilst this has had some effect WERA remains concerned about vehicles exceeding the speed limit on the road.

# CONSERVATION AREA STATUS FOR WARNER ESTATE?

**WERA WEBSITE** 

Last year at our Centenary meeting we raised the possibility of the Warner Estate becoming a conservation area. WERA has not progressed this because the Council conservation team is currently too preoccupied with carrying out "conservation area appraisals" of the 28 existing conservation areas in the borough. Another way of recognising the rich architectural and design heritage of our estate would be to start a collection of photos on our website or even possibly having a competition for the best original and new features.

#### TREES

Harry Aspden, on behalf of WERA, has developed a good relationship with Haringey Council tree officers in discussing what type of trees should be replanted on the estate when plane trees have to be cut down (usually due to insurance claims from householders). We want to have replacement trees that will, as far as possible, match the existing trees but not lead to subsidence. It was thought that Norway maple trees would be suitable but two young Norway maples have had to be cut down in Clovelly Road because they were damaging the pavement.

Linzee Road is a special case because it has no plane trees; in fact it has very few trees at all. Even with three new trees there are only eleven in the street. The tree officers have agreed that Linzee Road should have more trees but they have to allocate trees across the whole borough so we will have to wait.

Residents are aware of the increasing number of helicopters – some police, some private – in the area. At the moment there is little that can be done, although the Greater London Authority has commissioned a report into the subject.
